- 1. Submission is not open to Straumann employees.
- 2. Submissions must represent original research papers (hereinafter referred to as "Paper" or "Papers") in the area of oral implantology or dental tissue regeneration. The work/project may include basic, clinical and applied studies related to either oral implantology or dental tissue regeneration.
- **3.** The Paper submitted should not have been published and should not be published before the scheduled presentation of the Prize, although exceptions may be made.

- **4.** Papers must be in English.
- **5.** Papers should be submitted together with tables and labelled illustrations in the same scope and form as submissions for publication in scientific journals.
- 6. The Paper has to be submitted anonymously and should not include any indication that would reveal the identity of the applicant. The Paper should be placed in an unmarked envelope, bearing no name or reference. The Paper together with the completed Application Form stating the applicant's name and contact details are hereafter referred to as "Application Package". Application Packages will be handled by the Administration Officer who will allocate a code number to each application.
- 7. The Application is only valid if the Paper is completed and duly signed by the Applicant and submitted together with this Application Form. Application Packages should be sent by registered mail not later than by November 30, 2009 to the Administration Officer, André Schroeder Research Prize, ITI Center, CH-4002 Basel.
- **8.** The Applicant represents and warrants to be the exclusive author and exclusive owner of all rights related to the Paper submitted and that no manipulation other than cropping, rotating and/or adjustments of contrast and brightness have been performed on the digital images presented with the Paper.
- **9.** The Applicant represents and warrants that all information given in connection with the Application is true and valid.

## **Miscellaneous**

- 1. The Papers will be evaluated according their scientific relevance and content as well as their composition. If there are no submissions that are deemed worthy for the André Schroeder Research Prize, the Prize might not be awarded in 2010.
- 2. The Jury will evaluate all Application Packages which meet the requirements outlined in this Application Form and will communicate the selected Paper to the Administration Officer. The decision of the Jury is final and excludes recourse to the law. All Applicants, therefore, herewith irrevocably declare to refrain from taking all and any legal actions against the International Team for Implantology ("ITI") and/or Institut Straumann AG ("Straumann") and all its subsidiaries and affiliates as well as against the Jury and/or every individual member of the Jury.
